**By March 2007, the State of Connecticut's share the War in Iraq is estimated to reach \$ 9.2 BILLION!**  
Your town's share of this, and some of the major metropolitan areas, are shown below:

Greenwich	\$283.2 Million
Hartford	\$137.4 Million
New Haven	\$171.7 Million
New London	\$ 42.4 Million
Stamford	\$338.3 Million

Share of the cost of the War in Iraq is estimated to be:

# \$ 107.5 Million!

Instead of war, we could have:

- Paid for 1,158,020 children in Connecticut to attend a year of Head Start (7,129 Students in 2004).
- Hired 151,518 additional public school teachers in Connecticut for one year (Regular teachers 33,666 in 2001).
- Provided 423,844 students four-year scholarships at public Universities in Connecticut.
- Kids Health Insurance for 5,235,368 children in Connecticut for one year (Estimated 20,000 uninsured children in CT).

Estimates of the cost of the War in Iraq for towns, cities and counties across the U.S are based on those from [www.nationalpriorities.org](http://www.nationalpriorities.org).

- 1) The local cost of the war in Iraq is based on an estimated **total cost of \$378 Billion by March 1, 2007**. The details underlying these numbers can be seen at <http://costofwar.com/numbers.html>
- 2) The state share of the total is based on how much each state contributes in tax revenues, according to IRS data. **This is 2.43% for Connecticut.**
- 3) The town-level costs are based on **allocating the state share of the cost of the war in Iraq to towns based on the ratio of median local-level town income** to the total state income of \$74,556 Million (based on 2000 census data estimates).

Estimated Cost of War in Iraq (Million \$) = \$378, 000 Million \* (Median Household Income for Town) \* (Number of Households in Town) / \$74,556  
**Middletown: Median Household Income for Town = \$47,162 and 18,542 Households**
